The following disclosures are required to be made annually by all elected and appointed officials of Eureka City Corporation pursuant to Municipal Officers' and Employees' Ethics Act, Utah Code §§ 10-3-1306, 1307, and 1308 and Eureka City's Personnel Policies and Procedures Manual.

If additional space is needed, please use a separate sheet of paper. Per statute, the information provided shall be kept on file with the Eureka City Recorder and may be subject to disclosure to the public.

Ownership of a substantial interest is defined in U.C.A. 10-3-1303(10) as an interest of 10% or more of the shares of a corporation, or a 10% or more ownership interest in other entities, legally or equitably held or owned by the officer, the officer's spouse, or the officer's children.

*Note: There is no case law or statutory guidance as to what constitutes a business entity "subject to regulation of the municipality." A business which is simply issued a business license by the municipality may or may not be deemed by a court, administrative agency, an auditor, or member of the public to be an entity regulated by the municipality. Businesses regulated by interlocal agencies of which the municipality is a member may or may not be deemed to be a business regulated by the municipality (i.e., a restaurant subject to regulations imposed by an interlocal agency).

A business entity which requires a conditional use permit to operate may more likely be deemed to be a business entity regulated by Eureka City than a business that simply receives a business license from Eureka City.

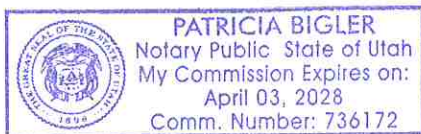
