

- ***Chip Seal Project***

Eureka City awarded the Chip Seal Bid to Johansen Construction, Inc.

The streets that will be done this year are: Eagle Street, Iron & O'Connor Street, Haulage Road, Jones Street, Upper Beck Street, Chief Street, Carlson Street, Hannifin Avenue and Hansen Street

Although we can't afford to do all the streets this year, we are planning to do at least a 1/3 of the streets each year so we can continue to make improvements and maintain what we have.

- ***Master Plans & Impact Fees***

To prepare for any future growth here in Eureka and protect the general welfare of its citizens, Eureka City has been working with Sunrise Engineering and Zions Bank to complete a Master Plan for Water, Wastewater, Transportation and Parks and Recreation, as well as establish Impact Fees for any new building lots and/or new developments. An impact fee is a fee that is imposed by a local government within the United States on a new or proposed development project to pay for all or a portion of the costs of providing public services to the new development. These fees are paid by the developer of the property, not the current citizens. Eureka City Council will hold a Public Hearing on September 9, 2019 at 6:30 pm to Introduce and take public comment on the Master Plans at the Eureka City Hall, 15 North Church Street, Eureka, Utah 84628.

- ***Utility Billing and Payment Options***

A few months ago, we started offering paperless billing to the Eureka City utility customers. With this option, customers can now receive their City Service bill and Eureka Review Newsletter by email instead of through the mail.

Currently, we have only had seven customers sign up for this service. So, if you no longer want all those papers stacking up, call or stop in the City Office to sign up for paperless billing.

We are also working on being able to offer on-line bill pay through our website using Xpress Bill Pay. The Council will be discussing this at the next Regular City Council Meeting.

Recipe Corner

Ada Randle's Apple Pie

"Remember: Apple pie without cheese is like a kiss without a squeeze."

Pastry:

2	c. Sifted Flour	1/2 tsp. Salt
1	Scant cup Shortening	Cold Water

Use only enough cold water to make a stiff dough. Don't handle too much. Line 9" pie pan with pastry and set aside.

Step 2 - Make the filling:

4 or 5	Large Cooking Apples:	1	c. Sugar
	Sliced or coarsely grated		Cinnamon (optional)

Fill pastry lined pie plate with apples and sugar, a little flour and dot with butter, layer until full. Wet the edges of crust with water. Cover top with rolled pastry. Make some decorative vents in top and brush top with a little canned milk, mixed with water, to help top brown. Bake 1 hour in 350° oven.
