#### NATURAL GAS

On August 27, 2020, Dominion Energy received the Final Order from the Public Service Commission to issue a Certificate of Public Convenience and Necessity authorizing Dominion Energy to construct and operate the pipelines and other facilities in Eureka, Utah and the surrounding areas and to provide natural gas service to Eureka, Juab County, Utah and the surrounding areas. Eureka City received the Final Order via email to Mayor Castleton from Brad Services Simons, Gas Development Consultant, Kev Accounts, **Business** Development & Social Contract. Anyone interested in reading the Final Order may do so by visiting the City Office and requesting to read the whole document. A copy of Exhibit A from that document has been included in this newsletter under NOTICES.

#### IMPACT FEES

On June 25, 2020, an Ordinance Adopting Impact Fee Analysis and Imposing Certain Impact Fees for Wastewater, Water and Parks, Recreation, Trails and Open Space; Providing for the Calculation and Collection of such fees; Providing for Appeal, Accounting and Severability of the Same, and other Related Matters, was adopted by the Eureka City Council.

Growth and Development Activities in Eureka City will create additional demands on the infrastructure. The persons responsible for the growth and development activities should pay a proportionate share of the costs of the facilities needed to serve the growth and development activity.

Before the Fees could took effect, we had to go through a 90-day waiting period. As of September 23, 2020, that waiting period is up.

Trails and Open Space

An impact fee is a one-time fee that is implemented by a local government on new development to help fund and pay for all or a portion of the costs of public facilities that are needed to serve new development. These fees are usually implemented to help reduce the economic burden on local jurisdictions that are trying to deal with population and commercial growth within the area.
